Introduction

This is the privacy and cookies policy www.israelbondsintl.com, ('Website'). The website is provided by Development Company for Israel (International) Limited, and Development Company for Israel (Europe) GmbH (each referred to as DCI). For the purposes of the Data Protection Act 1998, we are the data controller. We are committed to protecting your privacy on-line. We appreciate that you do not want the personal information you provide to us through the Site distributed indiscriminately and here we explain how we collect information, what we do with it and what controls you have. By using the Website, you consent to the collection and use of information in accordance with this privacy policy. Information we may collect from you

We may collect and process the following personal information about you:

Information you provide on any of the [investment forms](#) or [client information forms](#) that you print off, complete and send to us are not covered by this privacy policy. Please read our separate [Retail Client Terms of Business](#) and the information provided on our investment forms and for an explanation of how the information you provide on your investment applications will be held and used by us. You are under no obligation to provide information. However, if you choose to withhold requested information, we may not be able to provide you with certain services.

Uses made of your information:

We will use the personal information you provide to:

- enable us to respond to specific enquiries received from you and to provide you with the information offered through the Website and which you request.
- analyse the use of the Website and the people visiting in order to improve our content and services including research into our users' demographics.

You can tell us not to contact you with information regarding our products and services, either at the point such information is collected or, where you do not wish us to continue to use your information in this way, by following the unsubscribe instructions on any communications sent to you. You can also exercise this right at any time by contacting us using details at the end of this privacy policy.

Additional information

When you visit the Website, we may automatically collect additional information about you, such as the type of internet browser or mobile device you use, any website from which you have come to the Website and your IP address (the unique address which identifies your device on the internet) and your operating system, which are automatically recognised by our web server. You cannot be identified from this information and it is only used to assist us in providing an effective service on the Website and to collect broad demographic information for aggregate use.

Cookies and similar technology

The Website does not currently use cookies or other similar technology.

Information sharing

We may disclose your personal information to any of our affiliates, or to our agents or contractors who assist us in providing the services we offer through the Website, fulfilling requests for information, receiving and sending communications, analysing data, providing support services or in other tasks from time to time. Our agents and contractors will only use your information to the extent necessary to perform their functions.
